New Business (continued) - Linda Kusian made a motion to use that money to buy the computers. Chris Hunsaker seconded. The information will be taken to the congregation to vote on since this amount is over \$5000. The vote passed. He also discussed new wireless hardware and a new phone system with installation of those items, costing about \$2500 for each. A discussion took place.

Bill also talked about putting new carpeting in the nursery and the basement area of the church. That cost is estimated at \$7000-\$8000. The carpeting is the tile kind. Jim Sommers made a motion to use \$13000 from the Bosse Fund to cover the carpet, phone system, and wireless hardware. Gary Henningsen seconded it. The council voted and the motion passed. Again the proposal will be taken to the congregation to vote on.

The meeting was called to adjourn. A motion was made by Dave and Gary seconded it. Meeting adjourned. Pastor dismissed us with prayer.



FIRST ST. JOHN LUTHERN CHURCH COUNCIL MINUTES—February 16, 2010

The meeting was called to order by President Bill Caldwell and attendance was taken. The group was led in devotions by Pastor Blohm. The minutes of the last meeting were read and approved. Chris Hunsaker made a motion and Mike Winslow seconded and the motion passed.

Treasurer's Report - Jim Sommers gave the report. After the last council meeting Jim asked a few members what they needed to see in the new generated report. It has been scaled down. We are seeing balances in checking, reserve fund, and designated fund. Current expenses for Jan. were \$40,000. Some one-time expenses like insurance for \$11,000 occurred this month. End of Jan. was a shortfall of about \$16,000. Dave Warnke made a motion to accept treasurer's report and Bernie Erdmann seconded and the motion passed.

Board of Ed – The Sunday School goal is to have everything in the basement of the church. They are looking for storage for some clothing items. They will consider purchasing something to store them in. The Board of Ed will help manage the person working in the Nursery. They asked about carpeting in the basement.

Dayschool Report- Barb Shellhammer gave the report. She began by passing information out about Dayschool personnel. She spoke about the tax ID number that is shared between school and church. She asked other Dayschool entities around the country about that and those places all shared their number. She also showed a chart comparing our fees for Dayschool to others around Oregon. We are comparable in the daily fees as well as our fees for Kindergarten. An audit will take place before next council meeting. She also showed the financial report. The question was asked how many employees the Dayschool has, and Barb answered 19, not including subs.

Elder's Report – Mike Winslow gave the Elders report. They are set for the upcoming Lenten season to cover the services.

Finance Committee – The new finance chairman is Jim Sommers. There is no report at the current time.

Youth Report – Mary gave the report that the youth is settling in to their room in the basement. They made over \$1000 from their spaghetti dinner with \$500 coming from the dessert auction. She will be teaching about dating and relationships in Sunday School. In March or April there will be a movie night. She is planning for a mission trip in the summer. The youth had gone to see <u>How to Save a</u> <u>Life</u> written by a pastor. It touched on many issues that young people go through in their lives.

Pastor Report – Pastor is inviting all of us to a time with the Bishop in the evening on Mar. 2nd at Community of Christ in Waterville. There was a request from the commerce dept. to use a room for the Census Bureau in April 24- 30. They will be here from 8 am to 5 pm. There will be 4-5 people here. Pastor passed out some information about the Church Doctor. This is an outside consultant to help churches with their attendance, stewardship, spiritual growth and other issues. A group of members went to hear a short explanation of the benefits of having this group come in. A discussion followed. A person from the group will be at our March meeting so questions can be asked.

Old Business – Bill brought up that there needs to be a committee put together to plan for our 150 year celebration. He asked for a chairperson and other volunteers.

New Business – \$22,800 has been donated by our congregation to the Lutheran Home improvement. Bill then talked about networking our computers. His proposal from DELL came in at \$6,000. A server should be added to absorb all of the info from all the other computers in the building and to back up information. It also allows us our own email domain. The cost for this is about \$7000. He asked for a motion to move ahead with this project. Maintenance could run up to \$1000 per year as general maintenance. This money would come from the memorial fund.

Property Management – No report.
